**Explanation of Responses:**

- As previously reported, as compensation for service on the board of directors of the Company as an independent, outside director, the Reporting Person received an award of restricted stock units. Such time-based restricted stock units converted on a one-for-one basis.
- On March 9, 2019, the Reporting Person was granted 201,439 time-based restricted stock units, scheduled to vest, if at all, on March 1, 2020. Such time-based restricted stock units converted on a one-for-one basis.
- Following the transaction reported herein, 208,334 of such remaining restricted stock units are time-based and will vest, if at all, in two equal annual installments beginning on May 25, 2020. The Reporting Person deferred the receipt of 208,334 restricted stock units until January 1, 2021. The awards will terminate, and the applicable restricted stock units will not vest if the Reporting Person is not a director of the Company on the date the award is scheduled to vest.
